While the overall cost from the Pileum Corporation was less than the recommended vendor, Pileum responded with an access point that was not specified in the proposal. A careful review of the proposal and the alternate device specifications deemed the proposed alternate as not equivalent to the device specified.

On page 16 of the JPS RFP, the District outlined the following requirement:

*JPS currently has an existing Meraki Cloud Controller with Meraki Access Points located at each of the sites, and it is important to the district to maintain the functionality of this existing infrastructure. All access points, software, applications or hardware proposed that differ from the specified items must be compatible and equivalent to the existing Meraki infrastructure, including the cloud controller and must be 100% functional with the existing network.*
